AMENDMENT NO. 04 TO AGREEMENT

PARTIES

This **Fourth** Amendment to Agreement ("Amendment") is entered into between **Solano Community College District** ("District") and **Allana Buick & Bers, Inc.** ("Consultant"), collectively the "Parties").

RECITALS

WHEREAS, District and Consultant entered into an Architectural Engineering Services Agreement ("Agreement"), dated April 19, 2023, for services related to the District's **Vacaville Water Intrusion Project** ("Project"); and

WHEREAS, District and Consultant agreed to amend the Agreement to include additional design observation services to confirm repairs completed by building envelope contractor resolved leaks Via Amendment #1 on August 2, 2023; and

WHEREAS, District and Consultant agreed to amend the Agreement to include additional design services, construction administration, and post installation testing services Via Amendment #2 on October 18, 2023; and

WHEREAS, District and Consultant agreed to amend the Agreement to include additional design services, construction administration, and post installation testing services Via Amendment #3 on June 5, 2024; and

WHEREAS, District and Consultant agree to amend the Agreement to modify the services performed for the District's Vacaville Water Intrusion Project ("Project"); and

NOW THEREFORE, in consideration of the mutual promises and covenants set forth above and contained herein, District and Consultant agree as follows:

AGREEMENT

- 1. Section 1. Term of the Agreement is amended to read:
 - **1. Term.** Consultant shall commence providing services under this Agreement on May 1, 2023, and will diligently perform as required and complete performance by July 31, 2025, unless this Agreement is terminated and/or otherwise cancelled prior to that time.
- 2. Section 3. Compensation is amended to read:

Compensation. District agrees to pay the consultant for services satisfactorily rendered pursuant to this agreement a total fee not to exceed **One Hundred Ninety-Four Thousand, Three Hundred Twenty-Two Dollars (\$194,322)**. District shall pay consultant according to the following terms and conditions:

3. Exhibit A – Scope of Services is amended to include the following, in addition to the items already listed in the original agreement and all previous amendments.

This Amendment shall control over any inconsistencies between it and the Agreement and/or any previous extension(s) and/or amendment(s).
- 5. Consultant acknowledges and agrees that this Amendment shall not be binding on the Parties until and unless the Solano Community College District's Governing Board approves this Amendment.
