#### **AGREEMENT**

- 1. Section 2. Term of the Agreement is amended to read:
  - **2. Term.** Consultant shall commence providing services under this Agreement on May 15, 2024, and will diligently perform as required and complete performance by January 31, 2025, unless this Agreement is terminated and/or otherwise cancelled prior to that time.
