PARTIES

WHEREAS, District and Consultant previously amended the Agreement on November 20, 2024 (*Amendment #1*) for additional architectural services related to the District's **Campus-Wide Interior Refresh (Phase 1) Project** ("Project"); and

WHEREAS, District and Consultant previously amended the Agreement on February 19, 2025 (*Amendment #2*) for additional architectural services related to the District's **Campus-Wide Interior Refresh (Phase 1) Project** ("Project"); and

WHEREAS, District and Consultant agree to amend the Agreement to modify the services performed for the District's **Campus-Wide Interior Refresh (Phase 1) Project** ("Project"); and

NOW THEREFORE, in consideration of the mutual promises and covenants set forth above and contained herein, District and Consultant agree as follows:

AGREEMENT

- 1. Section 1. Term of the Agreement is amended to read:
 - **Term.** Consultant shall commence providing services under this Agreement on February 7, 2024, and will diligently perform as required and complete performance by July 16, 2025, unless this Agreement is terminated and/or otherwise cancelled prior to that time.
- 2. Except as set forth in this Amendment, all provisions of the Agreement and any previous extension(s) and/or amendment(s) thereto shall remain unchanged, in full force and effect, and are reaffirmed. This Amendment shall control over any inconsistencies between it and the Agreement and/or any previous extension(s) and/or amendment(s).
- 3. Consultant acknowledges and agrees that this Amendment shall not be binding on the Parties until and unless the Solano Community College District's Governing Board approves this Amendment.
