The consultant amendment is to extend the contract term and to provide additional support during the extended construction period. The project experienced delays due to ongoing coordination installing a fall protection system on the roof, as well as working around the school schedule. This change extends the contract time to August 30, 2025.

AMENDMENT #3 TO AGREEMENT

PARTIES

This THIRD Amendment to Agreement ("Amendment") is entered into between **Solano Community College District** ("District") and **HMR Architects, Inc.** ("Consultant"), collectively the "Parties").

RECITALS

WHEREAS, District and Consultant entered into a Consulting Services Agreement ("Agreement"), dated October 18, 2023, for Architectural Engineering Services for the design and construction administration of the **Fairfield Campus B1400 Modernization Project** ("Project"); and

WHEREAS, District and Consultant agree to amend the Agreement to modify the services performed for the District's **Fairfield Campus B1400 Modernization Project** ("Project"); and

WHEREAS, District and Consultant agreed to incorporate services to design replacement of lockdown hardware and electrification of the operators via Amendment #1 dated December 20, 2023; and an extension of the contract time via Amendment #2.

WHEREAS, District and Consultant desire to amend the Agreement to provide additional services and extend the time in support of the Construction Administration phase of the roof project to the consultant services;

NOW THEREFORE, in consideration of the mutual promises and covenants set forth above and contained herein, District and Consultant agree as follows:

AGREEMENT

1. Section 2. Term of the Agreement is amended to read:

Term. Consultant shall commence providing services under this Agreement on October 18, 2023, and will diligently perform as required and complete performance by August 30, 2025, unless this Agreement is terminated and/or otherwise cancelled prior to that time.

2. Article 4 of the Agreement is amended to read in its entirety:

Compensation. District agrees to pay the Consultant for services satisfactorily rendered pursuant to this Agreement a total fee not to exceed **One Hundred Ten Thousand, Seven Hundred Seventy-Five Dollars and Zero Cents** (\$110,775.00). District shall pay Consultant according to the following terms and conditions:

4.1 Payment for the Work shall be made for all undisputed amounts based upon the delivery of the work product as determined by the District. Payment shall be made within thirty (30) days after the Consultant submits an invoice to the District for Work actually completed and after the District's written approval of the Work, or the portion of the Work for which payment is to be made.

Except as set forth in this Amendment, all provisions of the Agreement and any previous extension(s) and/or amendment(s) thereto shall remain unchanged, in full force and effect, and are reaffirmed. This Amendment shall control over any inconsistencies between it and the Agreement and/or any previous extension(s) and/or amendment(s).
- 5. Consultant acknowledges and agrees that this Amendment shall not be binding on the Parties until and unless the Solano Community College District's Governing Board approves this Amendment.
