AMENDMENT #3 TO AGREEMENT

PARTIES

This **THIRD** Amendment to Agreement ("Amendment") is entered into between **Solano Community College District** ("District") and **HBI Inspections** ("Consultant"), (collectively the "Parties").

RECITALS

WHEREAS, District and Consultant entered into a Consulting Services Agreement ("Agreement"), dated April 17, 2024 for Division of the State Architect (DSA) Project Inspection Services related to the District's **B1400 Modernization Phase I - Roof Project** ("Project"); and

WHEREAS, District and Consultant agreed to time extension via Amendment #2 dated October 16, 2024; and

NOW THEREFORE, in consideration of the mutual promises and covenants set forth above and contained herein, District and Consultant agree as follows:

AGREEMENT

- 1. Section 2. Term of the Agreement is amended to read:
 - **2. Term.** Consultant shall commence providing services under this Agreement on April 17, 2024 and will diligently perform as required and complete performance by September 15, 2025 unless this Agreement is terminated and/or otherwise cancelled prior to that time.
- 2. Section 4. Compensation is amended to read

District agrees to pay Consultant fort services satisfactorily rendered pursuant to this agreement a total fee not to exceed **Forty Thousand, Two Hundred Sixty Dollars** (\$40,260.00). This fee is a total of the April 17, 2024 Agreement in the amount of \$24,840.00, Amendment #2 in the amount of \$12,420, and Amendment #3 in the amount of \$3,000.00. District shall pay Consultant according to the following terms and conditions: District shall pay consultant according to the following terms and conditions:

- 4.1. Payment for the Work shall be made for all undisputed amounts based upon the delivery of the work product as determined by the District. Payment shall be made within thirty (30) days after the Consultant submits an invoice to the District for Work actually completed and after the District's written approval of the Work, or the portion of the Work for which payment is to be made.
- 4.2. The itemized invoice shall reflect the hours spent by the Consultant in performing its Services pursuant to this Agreement. The Services shall be performed at the hourly billing rates included in **Exhibit "B."**
- 4.3. If Consultant works at more than one site, Consultant shall invoice for each site separately.

- 3. Except as set forth in this Amendment, all provisions of the Agreement and any previous extension(s) and/or amendment(s) thereto shall remain unchanged, in full force and effect, and are reaffirmed. This Amendment shall control over any inconsistencies between it and the Agreement and/or any previous extension(s) and/or amendment(s).
- 4. Consultant acknowledges and agrees that this Amendment shall not be binding on the Parties until and unless the Solano Community College District's Governing Board approves this Amendment.
